

## Lithuania - Passenger vehicle

### General Rental Information

The renter and the driver have to be in possession of a valid driving license.

Driving license printed with non-Roman Alphabet (Arabic, Japanese, Cyrillic etc) must be complemented by an International driving license.

Please show a valid ID card or passport at time of pick up.

### Special rental information by booking of Prepaid rates

#### Changing booking

A booking can be changed up to 48 hours before the start of the rental (on availability) in return for an alteration charge of 20.00 EUR. Any payment already made towards the rental will not be refunded; nor shall any differential amount be refunded if this alteration leads to a lesser rental cost.

#### Cancellation

A booking can be cancelled before the start of the rental. In the event of cancellation, the payment already made towards the rental will be paid back subject to a cancellation charge. The cancellation charge shall be the amount of the rental charge (including any extras and charges) for a maximum of 3 rental days. #### No-show

In the event that the booked vehicle is not collected or not collected at the agreed time, the rental charge already paid shall be withheld in full.

### Age Restrictions

In Lithuania, the following rules apply for the minimum age and possession of a driver's license: 19 years old /1 year for vehicles in group MCMR, ECMR, ECAR.

21 years old /2 years for vehicles in group CDMR, CDAR, CLMR, CWMR, IDMR, IDAR, IWMR, IWAR, IFMR, IFAR, FPAR, FVMR.

23 years old /3 years for vehicles in group SDAR, PDAR, LDAR, LVAR.

A Young Driver Surcharge of 60.00 EUR per day, max. 300.00 EUR per month started applies for drivers under 22 years.

### Conditions of Payment

#### Flexi Tariff

We accept all credit cards from internationally recognized credit card companies - such as American Express, Eurocard/Mastercard, Visa.

We do not accept any prepaid cards or debit cards (Visa Electron).

Sixt CarExpress Service card is only accepted in combination with a valid Credit Card.

Sixt also accepts AirPlus as payment.

To hire one of the following vehicles, customers must present two credit cards: SDAR, PDAR, LDAR.

#### Prepaid Tariff

The following credit cards are accepted: Eurocard/Mastercard, AmericanExpress Card, VISA Card. We do not accept any prepaid cards or debit cards (Visa Electron). The renter must be the owner of the indicated credit card. The authorized driver details and method of payment will be confirmed at reservation stage and cannot be amended. The confirmed credit card should be valid and available for presentation on collection of the vehicle. All extra costs that occur during the car rental will be charged to this credit card. By booking a prepaid rate, the credit card will be charged before the start of rental, directly with the estimated total amount of rental. The amount that will be charged on your credit card comprises the price of the rental as well as all additional extra fees. The rental charge (plus any other charges agreed, e.g. exemptions from liability, delivery charges, airport charges etc.) plus Value Added Tax in the statutory amount applicable from time to time must, as a matter of principle, be paid in full for the agreed rental period, i.e. if the vehicle is collected late or returned early there shall be no refund.

#### Generally

An advance charge approval is obtained for the chosen means of payment as a security. The exact deposit is determined on collection since the amount is dependent on the vehicle.

Please note, that payments with credit card may require the PIN of the credit card.

### General Protection Conditions

#### Third Party Insurance (TI)

Protection coverage for the vehicle includes Third Party Liability with a maximum cover of 5,000,000.00 EUR for personal injuries and 1,000,000.00 EUR for material damages. The hirer is liable up to the maximum amount of liability for accidents caused by the hirer, damage caused by parking, theft or any damage caused by an unknown third party.

Excluded from the protection is the use of the vehicle for the transport of dangerous goods. All protection as part of the rental contract will become void, in particular, if an unauthorized driver has used the vehicle or if the driver of the vehicle does not possess the required driver's license at the time of the event giving rise to claim.

Excluded from the protection is driving the vehicle in prohibited areas set by official order or driving the vehicle in off-road terrains.

### **Loss Damage Waiver (LDW)**

Loss Damage Waiver removes the driver's responsibility to a part of the vehicle in case of damage or theft.

If LDW is not accepted the customer **will be held liable for the full value of the car**.

If LDW is accepted, customer is only responsible for the following amounts:

850 EUR – M\*\*\*, E\*\*\*, C\*\*\*, I\*\*\*, FV\*\*.

1150 EUR – FD\*\*, S\*\*\*, P\*\*\*, LD\*\*, LF\*\*, FP\*\*.

1450 EUR - X\*\*\*, LV\*\*.

Excluded from the coverage are damages on tyres and windows.

### **Top Cover LDW**

If LDW is already included in the rates, the renter can choose Top Cover LDW to reduce/eliminate the Non-Waiverable Responsibility.

If Top Cover LDW is accepted, customer is only responsible for the following amounts:

425 EUR – M\*\*\*, E\*\*\*, C\*\*\*, I\*\*\*, FV\*\*.

575 EUR – FD\*\*, S\*\*\*, P\*\*\*, LD\*\*, LF\*\*, FP\*\*.

725 EUR - X\*\*\*, LV\*\*.

### **Super Top Cover LDW**

If LDW is already included in the rates, the renter can choose Super Top Cover LDW to reduce/eliminate the Non-Waiverable Responsibility.

If Super Top Cover LDW is accepted, customer is only responsible for the following amounts:

### **Tyre and Windscreen Coverage (TG)**

Tyre and Windscreen Coverage provides cover against the consequences of damages on tires and windscreen.

If TG is not accepted the customer will be held liable for the full value of damages on tires and windscreen.

If TG is accepted, customer is only responsible for the following amounts: 0.00 EUR.

### **Delivery & Collection**

Delivery/Collection Service is on request. Please contact the local rental station.

### **Out Of Hours**

An Out Of Hours surcharge of max. 40.00 EUR occurs for bookings out of opening hours.

### **One-Way Rentals**

#### **National**

One-Way Rentals within Sixt locations in Vilnius are free of charge.

#### **International**

International One Way Rentals are allowed to the following countries:

### **Cross Border Rentals & Territorial Restrictions**

Renter shall be entitled to use the rental vehicle exclusively in the territory of Latvia, Lithuania, Estonia; unless the Agreement states otherwise:

“**Zone 1**” – territory of Latvia, Lithuania, Estonia and Poland – free of charge;

“**Zone 2**” – Zone 1 and the territory of Andorra, Austria, Belgium, Bulgaria, Bosnia & Hercegovina, Czech Republic, Denmark, Finland, France, Greece, Croatia, Italy, Lichtenstein, Luxemburg, Macedonia, Monaco, Montenegro, Netherlands, Norway, Portugal, Romania, San Marino, Serbia, Slovakia, Slovenia, Spain, Sweden Switzerland, Hungary, Germany and Vatican – 100 EUR per rental;

“**Zone 3**” – Zone 2 and the territory of Ireland, United Kingdom – 150 EUR per rental;





“**Zone 4**” – Zone 3 and the territory of CIS – 200 EUR per rental (Renter must have Sixt letter of attorney for entering the territory of CIS). If the vehicle is used outside Agreement territory, Sixt shall be entitled to immediately terminate the Agreement without any sanctions on behalf of the Renter.. Renter shall certify that it has been warned that terms and conditions of the Agreement regarding personal liability, insurance, technical assistance, damage prevention, and/or replacement vehicle shall not apply if the vehicle is used outside the territories specified in the Agreement and/or insurance policy. In such case the vehicle insurance, technical assistance, damage prevention, and/or replacement vehicle shall be available for an additional charge.

### **Premium Location Fee**

A Premium location fee of 8% from rental days occurs for rentals at airport and train stations per month or part thereof.

From 01.01.2017 a Premium location fee of 8% on the non-reduced basis rental rate (T&M) occurs for rentals at airport and train stations.

#### Additional Driver

An Additional Driver Surcharge of 4.00 EUR per day applies.

#### Refueling Charge

All vehicles are supplied with a full tank of fuel and should be refilled prior to return to Sixt, otherwise our current refueling charges (3 EUR per liter) will apply.

Alternatively, you may purchase a tankful of fuel at the time of rental at a price that is competitive with local fuel stations and return the tank empty. No refunds will be given for unused fuel.

#### Other Fees and Taxes

##### Administration Fee For Fines and Fees

If the renter has a traffic/parking fine during the rental the renter will be charged an Administration Fee of 25.00 EUR together with the first settlement-proposition.

The renter is liable for payment of all traffic/parking fines occurring during the rental.

##### Smell-Removal-Fee

All Lithuanian Sixt cars are non-smoking cars. If a car needs additional cleaning/smell-removal caused by smoking, a fee of 250.00 EUR will be added to the invoice.

All rates are inclusive of VAT (if VAT incurs).

For corporate customers with individual agreements alternative prices and regulations can apply.
